Technical Areas of Collaboration

1. Encourage the students and teachers to conduct the research studies and publish papers in reputed journals.
2. Provide academic interaction by delivering Special Lectures at both colleges on topics of relevance to modern Industry.
3. Provide necessary mutual help in Organizing Workshops/Conferences at both the colleges for the enhancement of skills in respect of Faculty and Students of both colleges.
4. To facilitate the training programme for students and teachers.

Terms and Conditions

1. The conferences and activities conducted under the mutual agreement are under the MOU and the cost sharing is based on the agreement.
2. Both institutes agree to help, identify and invite faculty members and researchers from other institute to participate in conferences, workshops and research activities.
3. This MOU may be amended, renewed and terminated by mutual written agreement of the institutes at any time.

Confidentiality

- A. The De Paul Arts and Science College - Edathotty and Mahatma Gandhi College - Iritty agree to help in confidence all information/data designated by the institutes as being confidential which is obtained from either institute or created during the performance of the MOU and will not disclose the same to any third party without written consent of the other institute.
- B. The above confidential clause under this MOU excludes the information/ data possessed by either institute before entering into this MOU or independently developed and/or information already available through public domain.

Duration of MOU

This MOU, unless extended by mutual written consent of the institutes shall expire in Three years after effective date specified in the opening paragraph. However, on review, the MOU shall be extended for another two years by mutual consent.

Coordinators

Both institutes will designate persons who will have responsibility for co-ordination and implementation of this agreement.


