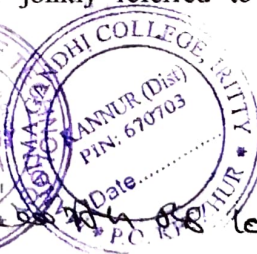

- C) Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interests.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MoU, THE PARTIES HERETO AGREE AS FOLLOWS:

CLAUSE 1 COOPERATION


Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the Institution and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.

First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the student and faculty of First Party providing significant inputs to them in developing student and faculty attitudes and aptitudes so as to direct them to the unfolding opportunities in management related career fields and undergraduate research, keeping in mind the needs of the evolving career scene.


The general terms of co-operation shall be governed by this MOU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MOU. The term 'Definitive Documents' shall be mutually decided between the Parties. Along with the Definitive Documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

CLAUSE 2 SCOPE OF THE MoU

The undergraduate students from the first party and Second Party could play a key role through Knowledge up-gradation, skill enhancement, innovation in the competitive environs of relevant industries. Both parties believe that close co-operation between the two would be of major benefit to the student and faculty community to enhance their skills and knowledge.

Skill Development Programs: First Party will help train the students to enhance the skill development program like presentation techniques, communication skills, hands-on training etc.

Invited Lectures: The First party and Second Party will mutually extend the necessary support, wherever possible, to deliver invited lectures to the students and faculty in different field relevant to them, on a need-based plan.

Faculty Development Programs: Second Party and First party will mutually support the faculty members so that they can train the students meet the industrial requirements, considering the National Occupational Standards in sectors concerned, if available. The First Party may organize workshops for the faculty members of the Second Party on screen recording and video editing, thereby equipping them with the professional skills to prepare, produce and publish videos of quality.

Student Exchange Programme: The First party and Second Party may send their students under different streams to these Institutions mutually for participating in orientation, career awareness and aptitude building programmes.

Academic Quality Enhancement: The Internal Quality Assurance Cells (IQAC) of the First and Second Party will work together to enhance the overall quality of the academic processes in both colleges, with special focus on raising the quality of the teaching process and student capability.

Collaborations for organizing Events: The First and Second party may organize Seminars/ Workshops/ Conferences/ Management fests collaboratively in each other's campuses, under mutually agreed upon themes and terms.

Add On Programme: The First and Second Parties will be providing assistance to each other in framing the curriculum and providing mutually agreed-upon sessions for the conduct of Add-on courses of the Management Studies department.

Campus Visit: As Inter- Institution interaction will help gather insights in to the latest developments / requirements of the industries, both the Parties shall permit the Faculty and Students to visit campuses and involve them in Training Programs. The industry-focused training and exposure provided to students and faculty through this association will build confidence and prepare the students to have a smooth transition from academic to career environs.

Internal and Evaluation: The First Party will help to prepare the internal question paper and evaluation of assignment, seminar etc.

Approvals: Both Parties are to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required for offering the Programmes on the terms specified herein.

Both parties need to reach a signed agreement regarding financial involvement, if at all, any, clearly stating their committed amount involved.

Confidentiality of Information and data: The information and data shared between the First and Second Parties will be kept confidential by both parties and will not be disclosed to any third party, partially or totally, without written consent of the parties concerned.

CLAUSE 3 INTELLECTUAL PROPERTY

Nothing contained in this MOU shall, by express grant, implication, Estoppel or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copy rights and designs) of the other Party.

CLAUSE 4 VALIDITY

This Agreement will be valid for a period of one year which can be extended up to 3 years on mutual consent. It can also be expressly terminated by either Party on mutually agreed terms, during which period, the First and the Second Party, as the case may be, will take effective steps for termination of this MOU. Any act on the part of the First or Second Party after termination of this Agreement by way of communication, correspondence etc., shall not be construed as an extension of this MOU

Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligation.

CLAUSE 5 RELATIONSHIP BETWEEN THE PARTIES

It is expressly agreed that **First Party** and **Second Party** are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.
