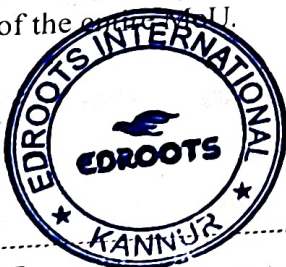

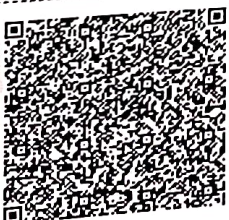

## RECITALS

Therefore, EDROOTS INTERNATIONAL and the COLLEGE agree as follows:

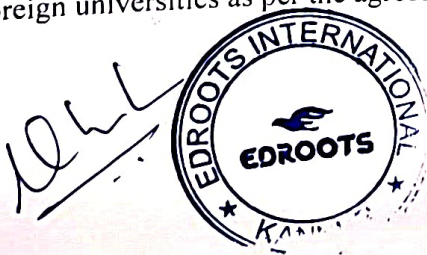

2. The Company will allocate separate student counsellors, certified by the British Council and other international bodies, following the events mentioned in Clause 1 for individual career counselling on a case-to-case basis. The counsellors will also provide their services on the sidelines of periodic events that may happen in the College during the academic year. The students can also avail the professional assistance of the Company's employees in choosing the right course-college-country (3Cs) combo and also in the further steps of admission, application processing and visa processing, and documentation.

3. The Company's services, mentioned in Clause 2, will be offered free of cost to the students of the College on a priority basis. In pursuit of this objective, the representatives and employees of the Company will actively participate in group activities and events happening at the College, as intimated by the Head of the Institution, from time to time, during the period of agreement.

4. We will provide assistance for one-on-one meeting with available university delegates at Edroots office as per the time and date decided by Edroots International. The students and parents will have the opportunity to interact with the delegates or representatives of different foreign universities as per the agreed schedule of both parties.

5. We will also organize mock tests and training sessions for IELTS and similar language proficiency tests at the college premises for students. It will help the students to gather information regarding IELTS test and its various aspects of reading, writing, listening and speaking, test session overview, band scores and test centers. Special discount will be provided to students of the College if they choose to enroll with Edroots International.

6. Students of the College can avail the professional advice of the Company's dedicated Assistant Manager the Company, so that the students will be rightly informed about the procedural formalities of availing an educational loan or other means of financial assistance which they are eligible for, including scholarships.

7. ### Termination

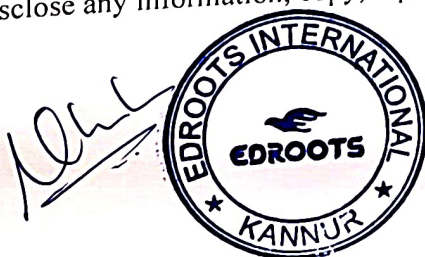
The Parties agree to comply with their agreed contributions to the project throughout its duration. Either Party may terminate this Agreement with one (1) month's written notice to the other Party

Licensee agrees to observe complete confidentiality with respect to the Company, and will not disclose any information, copy, reproduce or alter the Information provided.



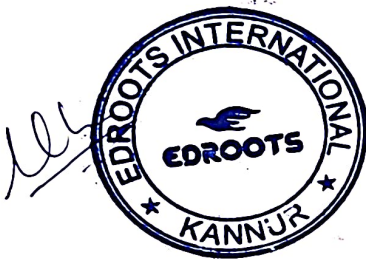


